- **1/30/2023 Motor Vehicle Theft, 04:27 AM (Simons Avenue):** Victim reports his vehicle was stolen from the front of his home on Simons Avenue. The vehicle's key fob was in the vehicle. Incident is currently under investigation.
- **1/30/2023 Burglary to Auto, 06:24 AM (Sutton Avenue):** Victim parked her vehicle on 1/29 in front of her home. Upon returning to her vehicle in the morning, she found the glove compartment open and the contents of the vehicle in disarray. This incident is currently under investigation.
- **1/30/2023 Theft, 10:18 AM (South River Street):** Complainant advised that unknown suspect(s) entered the fenced in area of the business and removed 4 catalytic converters. This incident is currently under investigation.
- **1/31/2023 Receiving Stolen Property 04: 48 PM (Prospect Avenue):** Officers responded to the area of Essex Street on a report of a located stolen auto. A motor vehicle stop was ultimately conducted in the area of Prospect Avenue and American Legion Drive. A juvenile operating the vehicle was taken into custody and transported to headquarters. Juvenile delinquent complaints were generated. The juvenile was released to his mother. The vehicle was turned over to the registered owner.
- **1/31/2023 Motor Vehicle Crash/ Driving while Intoxicated 06:30 PM (Spring Valley Avenue):** Officers responded to the area of Spring Valley Avenue on a report of a motor vehicle crash. Upon arrival they observed a two-car motor vehicle accident, with the arrestee asleep in one of the vehicles. A witness on scene informed officers that the arrestee's vehicle had also struck a vehicle on Main Street prior to the accident on Spring Valley Avenue. It was also determined that the arrestee was also involved in a motor vehicle accident on South River Street only a few minutes prior. The arrestee was taken into custody, transported to headquarters, and processed.
- **2/01/2023 Arrest 02:55 PM (Prospect Avenue):** Members of the Hackensack Police Department responded to Hackensack University Medical Center (30 Prospect Ave) on a report of a patient in possession of C.D.S. H.U.M.C. security turned over four (4) plastic baggies containing suspected crack cocaine. Complaints were generated and the arrestee was placed on a summons.
